Normas para elaborar el Learning Agreement (LA) - 1

- Se deben incluir en la ETSIME (tabla B) **un mínimo de 18 ECTS** para movilidades semestrales **o 36 ECTS** para anuales.
- Se deben incluir en destino (tabla A) **al menos tantos créditos ECTS** como los que se quiera reconocer en origen en la ETSIME (tabla B).
- Solo se podrá realizar un LA para realizar estancias correspondientes a **3º/4º curso de grado** o **2º curso de máster**.
- Para las movilidades en **4º curso**, se podrá incluir, excepcionalmente, una asignatura de 3º curso en movilidad semestral (del mismo semestre de la estancia), o dos asignaturas de 3º curso en movilidad anual.
- **No se podrán incluir** en el LA asignaturas matriculadas con anterioridad (**suspensas o no presentadas**).
- Solo se podrán incluir **asignaturas del mismo cuatrimestre** en caso de movilidad semestral.
- En asignaturas de **4º de grado** o **2º de máster**, se buscarán asignaturas similares en destino, asegurándose la viabilidad para cursarlas.
- Cada asignatura de **3º curso** incluida en el LA deberá tener una **asignatura equivalente** en destino en al menos el **75% del contenido**.
- Si se elimina del LA la asignatura equivalente en destino durante la estancia, se eliminará también la asignatura de 3º correspondiente.

Normas para elaborar el Learning Agreement (LA) - 2

- Se podrá incluir en el LA, además, la asignatura **“Inglés para la comunicación profesional y académica”**, siempre y cuando se acredite un **nivel B2** en inglés y la **enseñanza** en destino sea **en inglés**.
- Se rellenará un **documento complementario** al LA con la descripción breve del contenido de todas las asignaturas incluidas en destino, incluyendo enlaces a la fuente de información, y una tabla de equivalencias para 3º.
- Las **“Prácticas de empresa”** se reconocerán, si son obligatorias en la ETSIME, con prácticas de empresa en destino (“Internship”). En el caso de que sean optativas, se podrán reconocer por créditos de asignaturas de competencias o técnicas en destino.
- **El TFG/TFM será reconocible** siempre y cuando se entregue una copia en la ETSIME y cumpla unos requisitos mínimos (ver siguiente diapositiva).
- Si el **TFG/TFM** en destino tuviera más de 12 ECTS, los **créditos restantes** se reconocerán por asignaturas optativas en origen, salvo excepciones debidamente justificadas.
- Los créditos por **actividades acreditables no se pueden incluir** en la tabla de origen del LA.
- Únicamente se podrán usar los créditos de **asignaturas de competencias o de idiomas** para reconocer los correspondientes a las asignaturas optativas o de competencias en origen, salvo modificaciones debidamente justificadas por la universidad de destino.
